

“PLAY & RIDE ME” RULES AND REGULATIONS



1. You must be a Croc's Club Member or Hotel guest in order to participate in this sweepstakes.
2. Any person under 18 years of age or who is self-excluded, or who falls into any category of excluded persons, is expressly prohibited from gambling and or participating in the **PLAY AND RIDE ME** sweepstakes.
3. **Prize:** The PLAY AND RIDE ME sweepstakes sole prize is a “HONDA NAVI” year 2019. No cash or other prize substitution permitted except at Croc's Resort & Casino's and Sponsor's discretion. The last day to earn tickets is December 20th at 11:59 P.M. The last day Croc's will accept participating tickets will be December 21st at 7:00 pm.
6. **How to enter:** Croc's Club members and Croc's Resort & Casino guests are eligible to receive drawing tickets according to their play on slot machines or table games. The rules on how your play earns you tickets are on the back of this flyer. The Sweepstakes must be entered by submitting a ticket into the drawing drum located on the casino floor. The entry must fulfill all sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Croc's Resort & Casino. You may enter only once and you must fill in the information requested. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of Croc's Resort & Casino Any ticket with incorrect or altered information will be discarded. Mutilated, folded, crumpled or damaged tickets as well as tickets that have been tampered with, will not be deemed void and null and can be discarded at the discretion of Croc's Resort & Casino.

 - a- **Every Buy in of \$30 you get 1 Ticket.**
 - b- **Black Jack.**
1 ticket for a suited blackjack, Ace and 10, Jack, Queen or King of the same suit.
 - c- **Three Card Poker.**
1 ticket for straight.
 - d- **Craps.**
1 ticket for hitting a hard way with numbers 2 and 12 specifically.
 - f- **Pai Go**
1 ticket for full house.
 - g- **Roulette.**
1 ticket for hitting the current date with a straight up bet.

1 ticket per person every 2 hours on hours with even numbers (must be playing at the moment)
1 ticket for every jackpot over \$25.

Players who will like to earn tickets must be part of the players Club.

8. The Winner must present their Croc's Club card and valid photo identification to claim the prize. The receipt by winner of the prize offered in this Sweepstakes is conditioned upon compliance with any and all laws and regulations. 14. Disputes: THIS SWEEPSTAKES IS GOVERNED BY THE LAWS OF COSTA RICA, WITHOUT RESPECT TO CONFLICT OF LAW DOCTRINES. As a condition of participating in this Sweepstakes, participant agrees that any and all disputes which cannot be resolved between the parties, and causes of action arising out of or connected with this Sweepstakes, shall be resolved individually by arbitration in accordance with the bylaws of the International Center for Conciliation and Arbitration ("CICA"). The parties hereby agree to submit voluntarily and unconditionally to its rules and bylaws and claim knowledge thereof. The conflict shall be governed by the substantive laws of Costa Rica. The arbitration shall take place at the CICA in San José, Republic of Costa Rica. An arbitration tribunal of three arbitrators shall decide the matters subject to the arbitration procedure. The arbitrators shall be appointed as called for under articles 26 to 30, maybe as the case of Law on Alternative Resolution of Disputes, law No. 772, if not appointed by one or more the parties within the timeframe established in said law, they shall be appointed by CICA applying its rules. Further, in any such dispute, under no circumstances will participant be permitted to obtain awards for, and hereby waives all rights to claim punitive, incidental, or consequential damages, including reasonable attorneys' fees, other than participant's actual out-of-pocket expenses (i.e. costs associated with entering this Sweepstakes), and participant further waives all rights to have damages multiplied or increased.
